Following the release of the Welsh Government's proposals to reduce the number of local authorities, what should be done to best support integration between the reduced number of councils and LHBs, particularly where boundaries overlap? What other areas should be considered as priorities for investment in order to support integration such as infrastructure, technology and information services? How effective has the Intermediate Care Fund been in facilitating integration; and what measures should be taken to increase the accessibility to funds, particularly to the third sector? What further opportunities exist for other funding and programme support, including the European Social Fund (ESF)? How will budget reductions for local authorities in 2015-2016 impact moves towards integration and what should be done to address the funding disparity between health and social services?
